

## ARTICLES OF INCORPORATION

- (cont.) B. Every person or entity who is a record owner of any lot which is subject to covenants of record and to assessment by the Association shall be a member of the Association. The foregoing is not intended to inloude persons or entities who hold an interest merely as security for the performance of an obligation. Membership shall he appurtenant to, and may not be separated from ownership of any
- c. Upon dissolution of the Corporation, the Board of Directors after paying or making provision for the payment of all of the liabilities of the Corporation shall dispose of all of the assets of the Corporation exclusively for the purposes of the Corporation by conveying these assets in such a manner, or to such an organization or organizations organized and operated exclusively by a non-profit corporation for similar purposes or by dedicating these assets to a Public Body.
- Any amendment to these Articles of Incorporation shall require the approval of not less than 90% of all members during the first twenty (20) year period of existence of this corporation and not less than seventy-five percent (75%) of all members thereafter.
