Hello Everyone ... and Happy New Year

Time to roll up our sleeves and tackle 2020!!

As I have said many times, if we all just pull in the same direction, we are limited only by our own imaginations. I'd like to challenge everyone to make a New Year's Resolution ... Come up with one thing (it can even be a little thing) ... one thing that you can do for all the rest of us – your contribution to the "wagon pull."

Some things we really need are: More volunteers to staff the Hotline; more volunteers on the Environmental Protection Committee. But, little things can make a big difference as well – like, picking up trash if you see some that has been blown around; picking up those little lawn service notices after the service date – you know, the ones that are placed at the mailboxes.

Finally, we can all just take care of ourselves:

- <u>Read the rules</u>. The rules apply to all of us. If you need a special accommodation (like using a parking pad for a specific period; or a need to place your trash out early), please call us. We are happy to work with you so that you can avoid being fined for a rule violation.
- <u>Send in that Alteration Request</u>: Please remember you must submit an alteration request for any and all work done on the outside of your residence. The word "alteration" is a bit

confusing. The rule applies even if you are not actually "altering" something – for example, painting the same color; replacing a storm door with exactly the same kind of door. If you're confused, call your EPC Representative or the Steeplechase Hotline.

Contract with Comcast

If you attended the Annual Owners' Meeting in November, we announced our intention to sign an Exclusive Marketing Agreement with Comcast. That Agreement has now been signed and becomes effective January 15, 2020, and will remain in effect for 10-years with automatic 2-year renewals thereafter unless either party gives notice of a desire to cancel.

First, no fears!! <u>The Agreement does not affect your individual right to choose whatever</u> provider you wish for TV, Internet and Voice services.

The Association's responsibility under the contract is to permit Comcast – exclusively – to market their products in Steeplechase. For example, Comcast will provide us with marketing information that we will include in our Welcome Packets for new residents; Comcast will sponsor social activities in an effort to entice more residents to switch to Comcast. All of these things will be at the expense of Comcast.

In exchange for the exclusive marketing rights, Comcast will pay us an up-front lump sum equal to 100/unit -or 34,800. We will receive this payment during the first quarter of 2020. On an ongoing basis, we will receive quarterly "revenue sharing" payments which will be based on the number of units using Comcast for TV, Internet, and/or Voice.

The compensation arrangement is slightly different from the one we discussed at the Owners' Meeting. Initially, we were going to opt for a higher up-front lump sum with no revenue sharing. After we looked into it further, however, we determined that the revenue sharing has the potential of providing a nice steady income stream.

For this first year, the Board has decided to allocate these funds (i.e. both the lump sum payment and any revenue sharing payments) to the Operating Budget – you will see the lump sum payment listed as "Comcast Commission" in Account #47850 on the 2020 Budget you received recently. The Board has asked the Finance Committee to provide an investment recommendation. There is no mention of the Revenue Sharing payments because Comcast has not yet told us what these will be.

Allocation

In addition to adding the Comcast payment to the Operating Fund, and with the help and advice from the Finance Committee, the Board approved a change to the allocation of monthly assessments between the Operating Fund and the Repair and Replacement Fund. In the past, we have allocated 20% of the monthly assessments to the R&R Fund – 80% to Operating. As you all know, the Finance Committee has done an outstanding job of investing the R&R funds. That Fund has grown so significantly that we decided to allocate only 10% to R&R and 90% to Operating for 2020.

The Board and the Finance Committee will review the impact of these decisions at the end of the year and assess how to proceed going forward.

We're all looking forward to a new year. Do your part to help us make Steeplechase the best that it can be! The benefits flow to all of us.


