#### PRESIDENT'S NEWS

Hello Everyone and Happy New Year

It's been a while. I think our last Newsletter was in October – so, we have a lot to catch up on. Let's get to it!

#### ANNUAL MEETING

#### Financials ...

The majority of votes from Homeowners was to do no review or audit of the 2024 Financials. On behalf of the Board, thank you for that vote. Mr. Joe Sunseri, the Chief Financial Officer for CMA, came to the meeting, answered questions and provided information to help Homeowners make that decision. Mr. Sunseri talked about the number of CPA firms who no longer provide these services to HOAs and the changes to the Accounting Rules which caused the cost of these services to have more than doubled. Mr. Sunseri stated that only 6 of CMA's clients continue to have year-end financials reviewed or audited; and, of those 4 do so because of requirements in their Declarations.

The cost of having these services done has really changed the playing field. When Steeple-chase Homeowners voted to have no review or audit done to the 2023 financials, the Board was able to redirect budgeted funds to other things – like the new fountain, the new "Welcome" sign on Caste, cutting down the trees beloved by lantern flies and cleaning up that area and planting new trees. At the time of this year's meeting, the Board had not completed the budget for 2025 pending the outcome of this vote. Since the Homeowners once again voted not to do either a review or audit, the Budget has since been finalized without a need to increase the monthly assessments.

## Voting ...

As you know, we have been making the Ballot Boxes available so that Homeowners who are unable to attend meetings can cast their votes in advance. We've learned that, with the use of the boxes, many more Homeowners vote. Voting in advance of the meeting, however, does not comply with the literal language in our By-Laws, and the practice was challenged at the Meeting. With regard to the vote on the Financials, the votes were counted twice — once by including all votes (whether cast at the meeting or in advance) and once counting only those cast at the meeting. The results were the same.

Going forward, we would like to amend the language in the By-Laws to specifically permit Homeowners to vote in advance of the meeting. We will prepare a proposed amendment and submit it to Homeowners for approval.

We all know the saying about death and taxes. So the major news from Whitehall Borough for the new year is a .5% real estate millage increase which will net the Borough \$400,000.00. There will be another .5% increase in 2026. This increase was approved by a 5 to 2 vote. To get some idea of the rationale for the increase I would refer you to the video of the Borough Council meeting for December 4 (20min:50sec) and December18 (59min:35sec). These can be found on the Whitehall Borough official site at whitehallboro.org.

At the January 15<sup>th</sup> Council meeting, Mayor Nowalk addressed a correspondence made by one of the Council members concerning the tax issue. Steeplechase residents may have seen this information on the Steeplechase facebook page. This correspondence compared Whitehall taxes with Mount Lebanon and Upper St. Clair. Mayor Nowalk did an in depth analysis of our taxes (realty and wage) in relation to these two communities. He included the school district in another calculation. His analysis follows:

Municipality	Wage & Realty Tax per Resident	Tax including School District
Mt. Lebanon	\$888.00	\$ 3,688.00
Upper St. Clair	\$1,069.00	\$4,962.00
Whitehall	\$658.00	\$2,346.00




